The Corporate Secretary announced that public notice of this meeting was posted in the lobby at One Port Center and provided to representatives of the area news media. Mr. Lawless then called the roll and announced that a quorum was present.

### **Report of the Chief Executive Officer – April 21, 2010**

Mr. Matheussen submitted his report as it stands. Mr. Matheussen recognized the March Employee of the Month, Eulisis “Del” Delgado. Del is with the Equipment Department at PATCO and has been on staff for the last 15 years. Del’s nominator called the Authority’s attention to his hard work during the past snow storms and their aftermath where Del worked tirelessly to keep the train doors clear of snow and ice. As a result of his efforts, the Authority did not lose any trains due to door failures during this period. As Del’s nominator noted, “his actions helped provide the best service possible during severely adverse conditions”.

Mr. Matheussen went on to recognize retiree Bock Eng. Bock has been with the Authority for 30 years at PATCO and is retiring from his position as a Supervisor in Transit Services. The Authority thanked Bock for all of his valued years of exemplary service and wished him well in his new endeavors.

Mr. Matheussen recognized Lt. Jack Stief. Lt. Stief could not be at the Board Meeting. He recently graduated from the prestigious FBI National Academy Program at Quantico, Virginia. Jack was one of 253 law enforcement officers from 50 states and 20 international countries who were invited to attend the Academy. The rigorous program offers 10 weeks of advanced investigative, management and fitness training for officers selected for having proven records as professionals within their agencies.

Next, Mr. Matheussen congratulated the Authority’s Chief Operating Officer, Tim Pulte, who has been honored by his Alma Mater, Indiana University of Pennsylvania, by being one of 5 alumni this year inducted into the Eberly College of Business and Information Technology Hall of Distinction. Tim was recognized for professional success and good citizenship.

Further, Mr. Matheussen informed the Board that DRPA has received \$760,000 from a High Priority Project (HPP) appropriation under Congressman Brady’s 2009 Appropriations Bill. This grant will go toward the installation of elevators at the 9<sup>th</sup>/10<sup>th</sup> & Locust PATCO Stations in Philadelphia, allowing us to provide increased accessibility for the public, which is particularly appropriate in an area of the City that contains three hospitals.

Finally, Mr. Matheussen spoke about the South Jersey PATCO Expansion project. The Authority has progressed from the end of the Alternatives Analysis to the next phase of the project where the Authority is collaborating with the Federal Transit Administration (FTA) to complete an Environmental Impact Statement (EIS) for the proposed light rail line from Glassboro to Camden, the Glassboro Camden Line, or GCL. This past Monday, April 19<sup>th</sup>, the Authority rolled out the new name for the project, GCL, and the Authority announced there will be public comment meetings scheduled for the Environmental Impact Statement. The first session will be held on Thursday, May 6<sup>th</sup> between 5:30 p.m. and 8:30 p.m. at the Camden County College Technology Center here in Camden. The other two public comment meetings will be held on Tuesday, May 11<sup>th</sup> at Rowan University’s Henry M. Rowan Building in Glassboro. The first session that day is from 1:30 p.m. to 4:30 p.m. and the evening session that day is from 5:30 p.m. to 8:30 p.m. In addition to the public comment meetings, those wishing to comment may also do so via mail, fax or email. Information on all comment methods is available at the project website, [www.GlassboroCamdenLine.com](http://www.GlassboroCamdenLine.com). The

Authority encourages all to take a minute and look at the website. It has a great deal of information about the project and is very informative as to what we are accomplishing in the Authority's efforts to bring much needed additional mass transit services to our region. Mr. Matheussen congratulated Bob Box, Cheryl Spicer, Mike Venuto and the PATCO Study team for their hard work to advance the project.
